

MINUTES

The online meeting of members of the HCHS who had not paid the additional amount held on 12th June 2021. Chairman appraised the members about the development of the Land Pooling Policy and progress about formation of consortium. Chairman requested the members to pay their additional amount/land cost latest by 31st August 2021 as it is a cooperative mission. After having discussions in the meeting the following points were agreed:

1. It was pointed out by members that some other members are pursuing them not to pay the additional amount/land cost and confusing them for the progress of the consortium and other related development in DDA's Land Pooling Policy. Chairman cleared all the confusion of the members one by one and told about the progress of the society and DDA's Land Pooling Policy.
